I hereby affirm that I am licensed under provisions of Chapter 9 (commencing with sec. 7000) of Division 3 of Business and Professions code, and my license is in full force and effect.

I have and will maintain worker's compensation insurance as required by sec. 3700 of the labor code, for the performance of the work for which this permit is issued.

INDIVIDUAL CONTRACTOR. I certify that in the performance of the work for which this permit is issued, I shall not employ any person in any manner so as to become subject to the worker's compensation laws of California, and provisions of sec. 3700 of the Labor Code.

I have and will maintain a certificate to self insure for worker's compensation insurance. As provide for by sec. 3700 of the labor code, for the work for which this permit is issued.

Owner Declarations

I as owner of the property, or my employees with wages as their sole compensation, will do the work, and the structure is not intended or offered for sale (se. 7044 Business and Professions code). The Contractors license law does not apply to an owner of the property who builds or improves thereon, and who does such work himself or herself or through his or her own employees, provided that such improvements are not intended or offered for sale. I, as owner of the property, am exclusively contracting with licensed contractors to construct the project (sec. 7044, Business & Professions Code: The contractors license law does not apply to an owner of property who builds or improves thereon, and who contracts for such project with a contractor(s) licensed pursuant to the contractors license law.

I have carefully examined the completed "Application and Permit" and do hereby certify under penalty of perjury that all information hereon including the declarations are true and correct, and I further certify and agree if a permit is issued, to comply with all city, county, and state laws and ordinances governing the City of El Cajon against all liabilities, judgments, cost, and expenses which may in any way accrue against said City in the consequence of the granting of this permit. I also hereby authorize representatives of this City to enter upon the above—mentioned property for inspection purposes. I have declared status with regard to workers compensation laws on this form. My signature on this form constitutes my agreement to this declaration. Expiration: Every permit issued by the Building Official under the provision of this code shall expire by limitation and become null and void, if the building or work authorized by such permit is not commenced within 180 days (or a length of time as set by the Building Official herein (___ days) from the date of such permit, or if the building or work authorized by such permit is suspended or abandoned at any time after the work is commenced for a period of 180 days.
